**NARRATIVE**

Unit 1 is a 3 axle trash truck which was stopped facing northbound on King Avenue across from 560 King Avenue, but stopped on the wrong side of the roadway. The driver admittedly had stopped, and was attempting to exit the vehicle at the time of impact.

Unit 2 acknowledged knowing that Unit 1 was on the street, and proceeded to back form the driveway of 560 King Avenue. Unit 2 failed to maintain or verify the position of Unit 1 when backing, and during the process, struck Unit 1.

Point of impact to each vehicle was on the right rear corners. Unit 1 sustained no visible damage except paint transfer, and Unit 2


