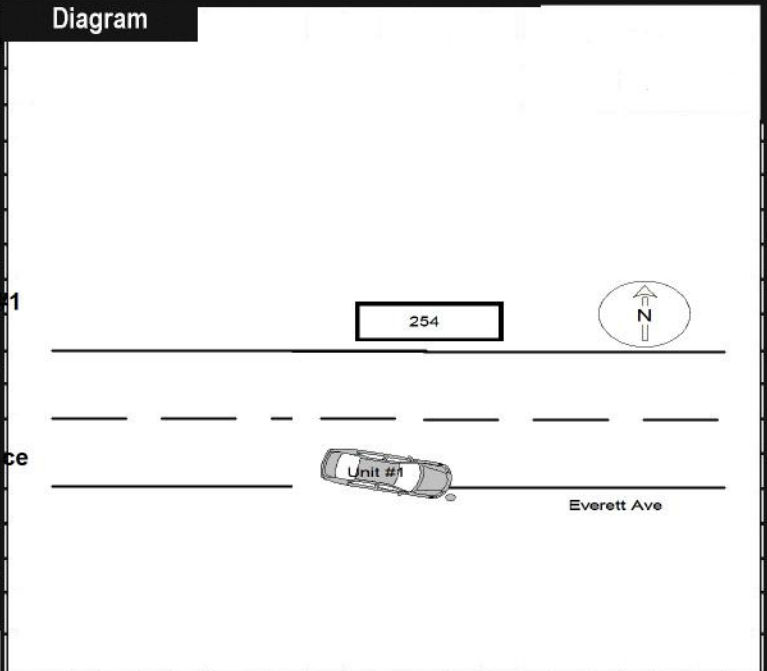
NARRATIVE
