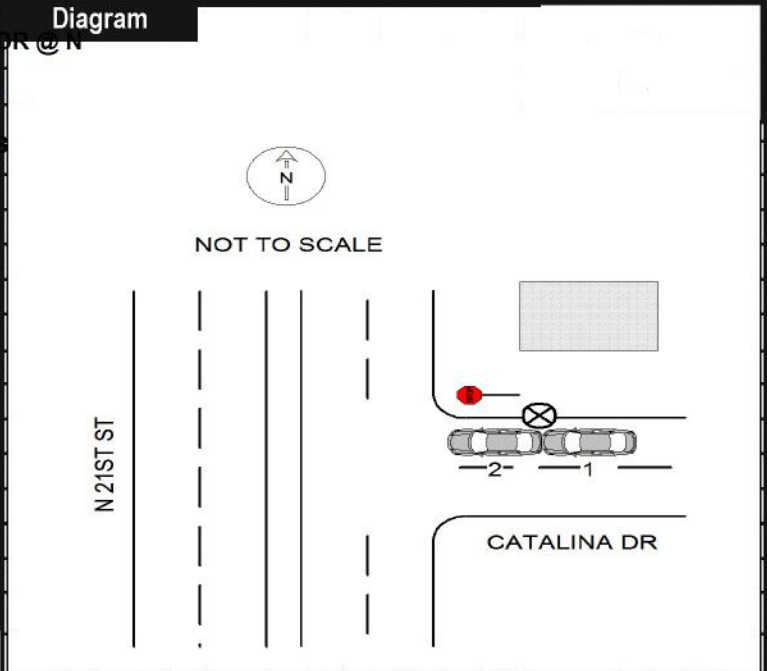

FOUND AT FAULT FOR THE ACCIDENT FOR ACDA.




