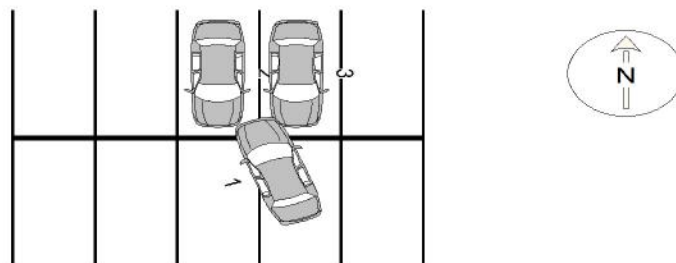

NARRATIVE

Unit #1 was attempting to park in the Ollie's parking lot, 1650 N. 21st Street. As the driver turned into a spot, the driver of the vehicle parked in the space to the right of Unit #1 opened her door abruptly and exited her vehicle. Fearing that she was going to strike the pedestrian with her vehicle, the driver of Unit #1 swerved and attempted to apply the brake. Instead, the driver of Unit #1 stepped on the accelerator. Unit #1 struck the two parked cars in front of her, Unit #2 and Unit #3. All three vehicles were able to be driven from the scene.

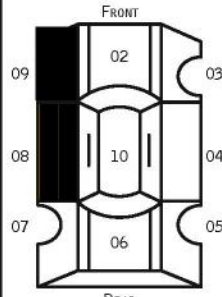
