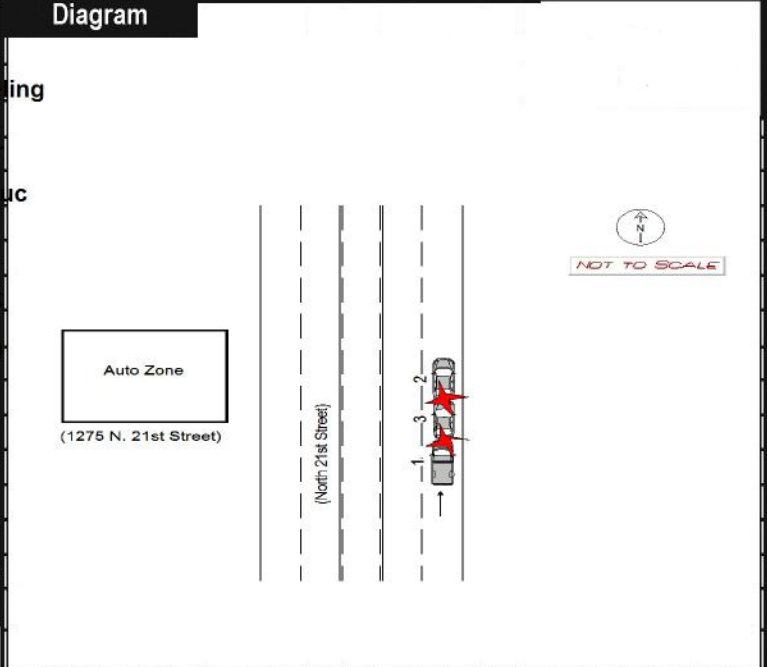

NARRATIVE
07/01/2017, 1457 hours, Unit#02 was traveling North on North 21st Street and stopped near 1275 North 21st Street. Unit#03 was traveling behind Unit#02, in the same lane, and Unit#01 was behind Unit#03. Unit#01 failed to maintain an assured clear distance ahead and struck Unit#03 in the rear. The force of impact sent Unit#03 into Unit#02. (Note: operators of Unit#02 and Unit#03 complained of injuries but none wanted transported by responding Newark Fire Dept Medics)
