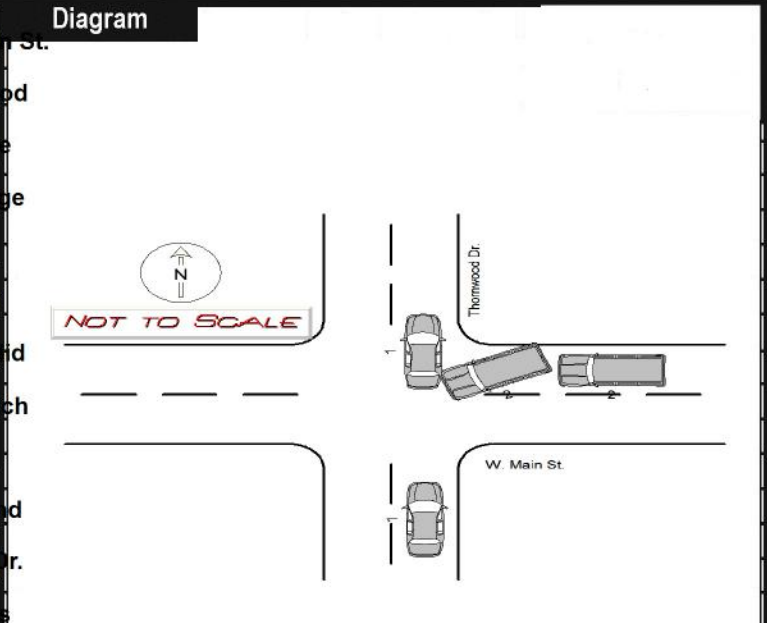
**NARRATIVE**

Unit 1 was stopped at the stop sign n/b on Thornwood Dr. at W. Main St.

Unit 2 was stopped at the stop sign w/b on W. Main St. at Thornwood Dr. The drivers of unit 1 and 2 exchanged information, however, the driver of unit 1 contacted Newark P.D. after realizing that the damage was more severe than he first realized.

The driver of unit 1 provided a name and insurance for the driver of unit 2. The driver of unit 1 could not provide a phone number but did provide a license plate number. The registered owner of unit 2 matched the name provided to the driver of unit 1.

The driver of unit 1 advised that he went through the intersection and was almost cleared when unit 2 made a left turn onto Thornwood Dr. striking the rear right side of his vehicle. The driver showed photos


