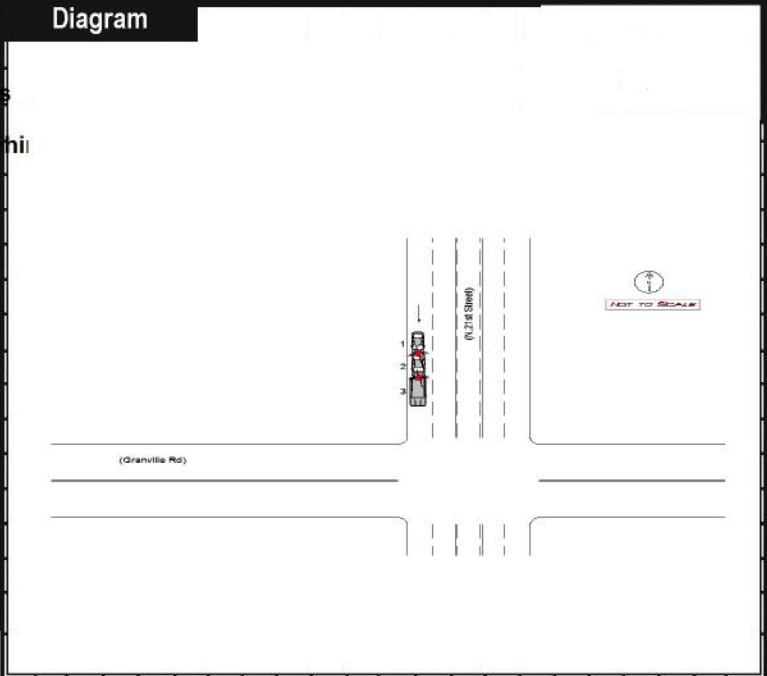

Unit#02 was traveling behind Unit#03, in the same lane, and slowed/stopped behind it. Unit#01 was traveling behind Unit#02 and struck Unit#02 in the rear. The force of impact sent Unit#02 into the rear of Unit#03. Unit#01 failed to maintain an assured clear distance ahead.
