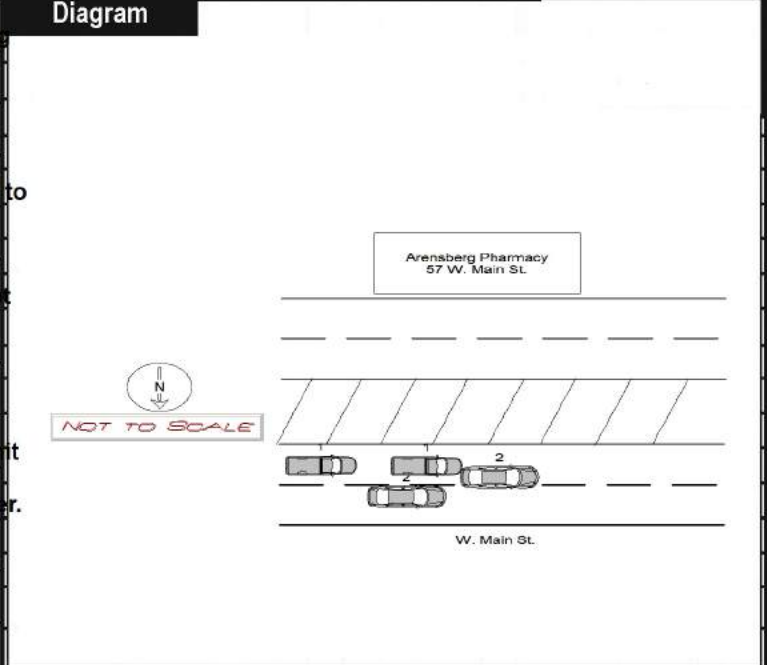

**NARRATIVE**

Unit 1 and 2 made a left turn from S. 4th St. onto W. Main St. heading westbound. The driver of unit 1 stated that unit 2 merged into the right lane and he was in the left lane. The driver of unit 1 said that unit 2 made a left lane change without warning and he was unable to stop in time to avoid striking unit 2. The driver of unit 2 stated that she was in the left lane and was turning left into a parking spot when she was struck from behind by unit 1.

Unit 1 had minor damage to the front right portion of the vehicle. Unit 2 had minor damage to the rear left bumper and rear left side fender. The impact location on unit 2 was on the rear left side of bumper.

Unit 2 changing lanes in front of unit 1 appears to be the only

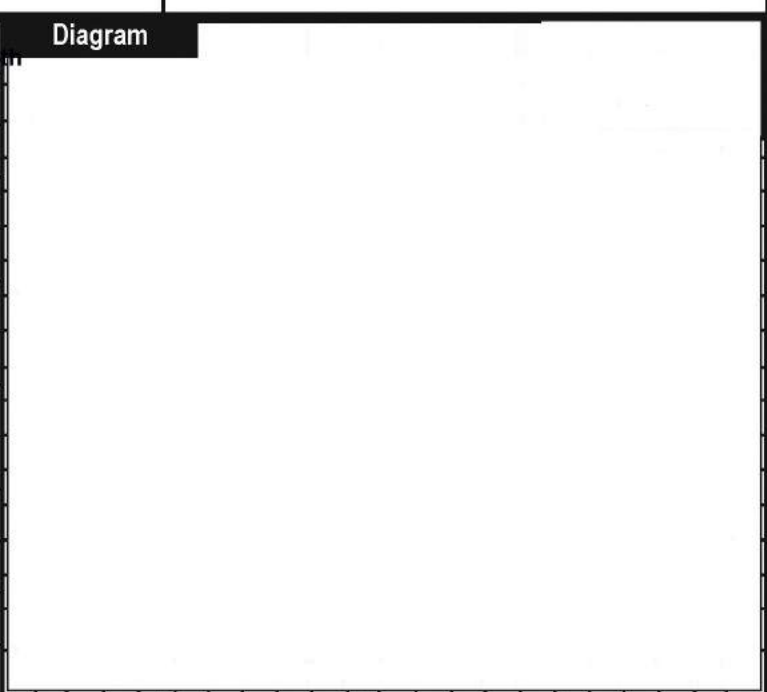
