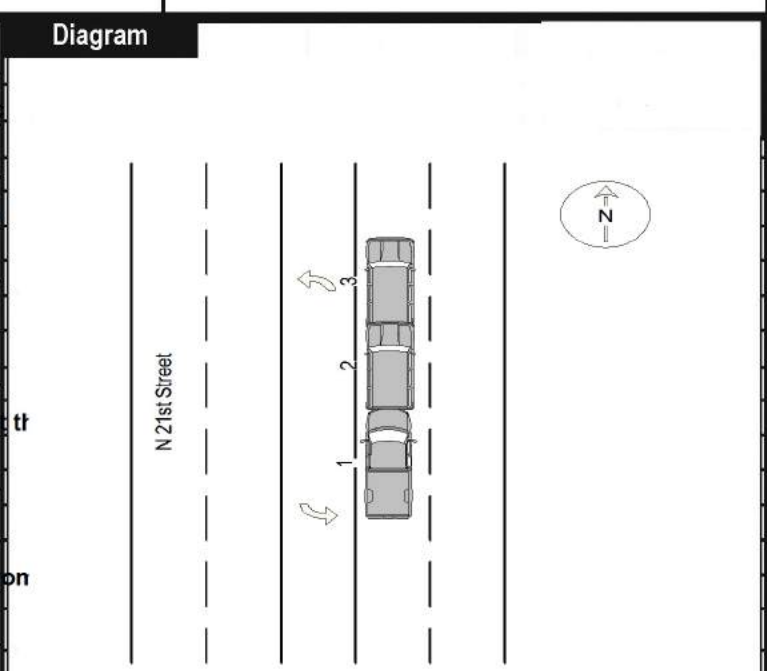
NARRATIVE

Unit #3 was traveling n/b on N. 21st Street followed by Unit #2 and Unit #1 respectively. Unit #3 and Unit #2 were slowing due to traffic in front of them. Unit #1 was unable to slow his vehicle in time to keep from striking the rear of Unit #2. The impact forced Unit #2 to strike the rear of Unit #3.

The driver of Unit #1 stated that traffic stopped abruptly in front of him and he believed that he was traveling approximately 35 mph at the time of the accident.

Units #2 and #1 sustained disabling damage and had to be towed from scene.




