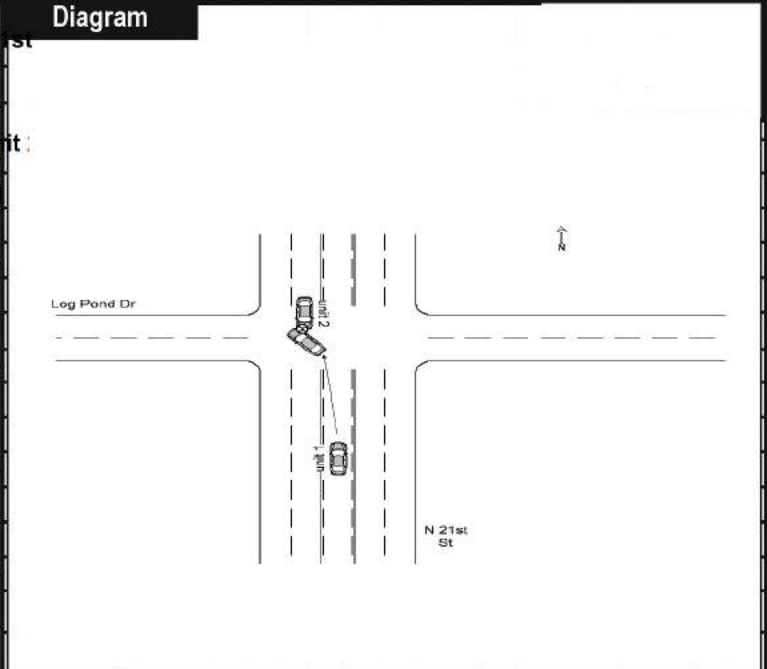

**NARRATIVE**

On the stated date and time unit 1 was traveling northbound on N 21st St in the area of Log Pond Dr. Unit 1 made a left hand turn to go westbound onto log pond dr. While turning unit 1 was struck by unit 2 which was traveling southbound on N 21st St. It is unclear if unit 1 failed to yield to unit 2 or if unit 2 ran a red light. There was disabling damage to both vehicles and no reported injuries.


