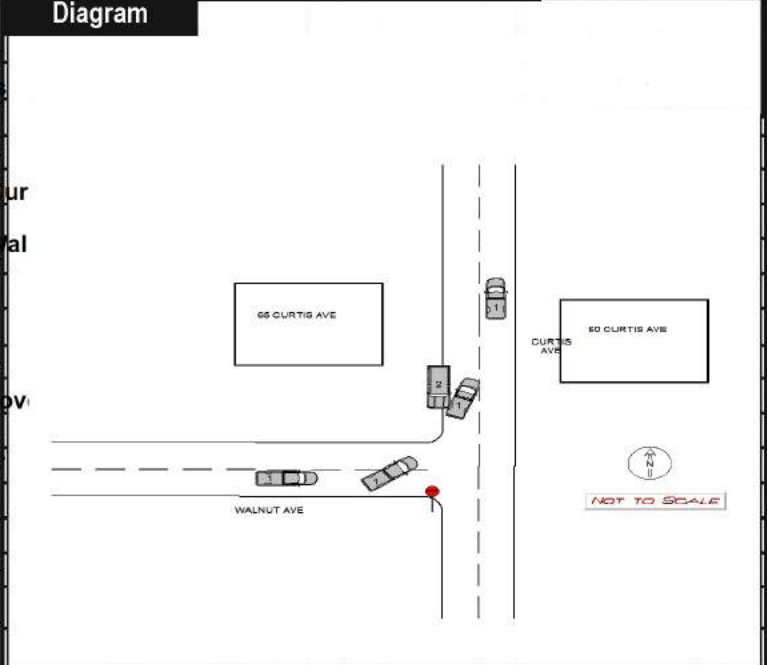

Unit#1 was traveling at high rates of speed East on Walnut Ave approaching Curtis Ave. Witnesses stated Unit#1 turned North onto Curtis Ave from Walnut Ave with the deputies in pursuit. Witnesses state Unit#1 cut the corner in the Southbound lane of Curtis Ave. striking Unit#2. Witnesses stated Unit#1 continued North on Curtis Ave. Unit#1 drove off the road near the intersection of East Main St. and Dayton rd.**




