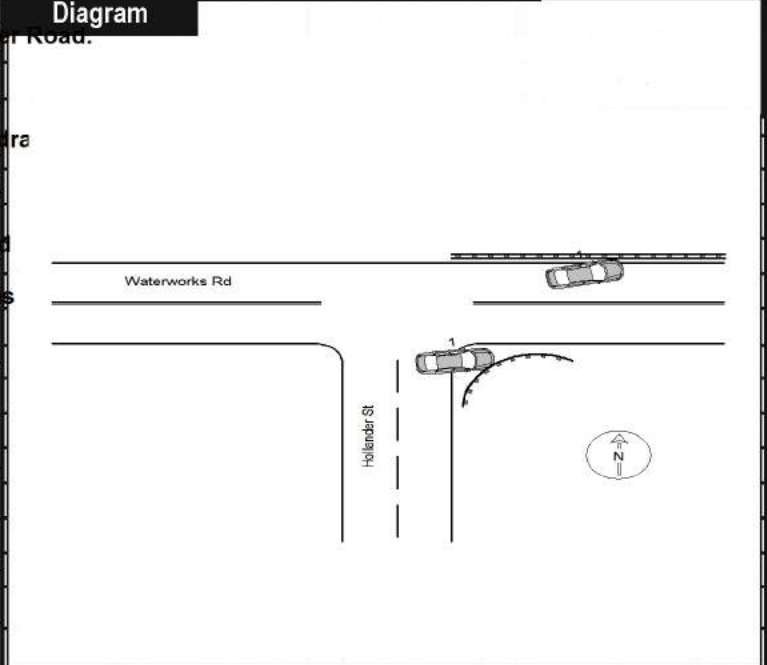

NARRATIVE
Unit #1 was traveling eastbound on Waterworks Road near Hollander Road.
The listed witness stated that the vehicle was traveling along the curb and the driver was unconscious. The vehicle struck the guardrail at the intersection of Hollander street, crossed over the center line and then went off the left side of the roadway, and struck the raised sidewalk and bridge railing. The driver was transported to LMH. It is believed that he suffered a medical emergency prior to the crash.
