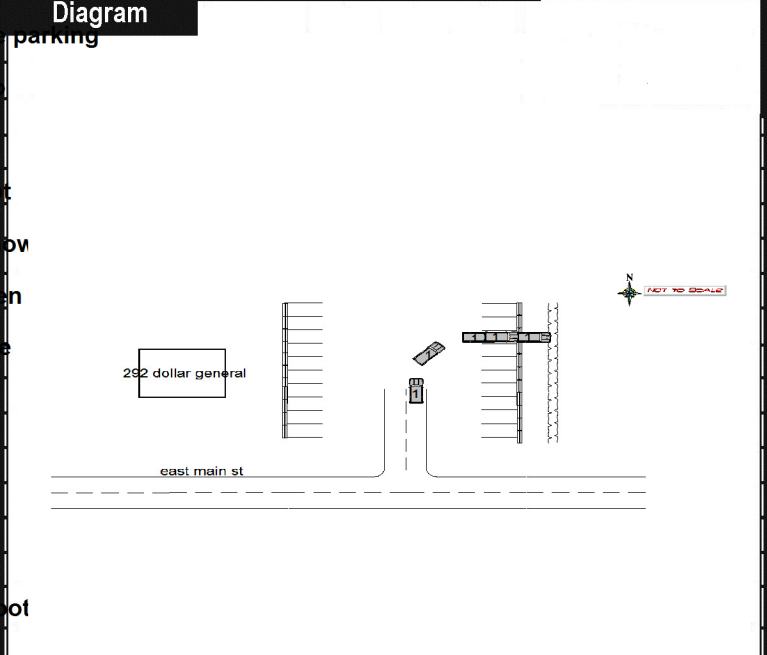

WITNESSES STATED THEY LOCATED Unit#1 on the East side of the parking lot of the Dollar General store. Witness#1 stated when he spoke to the driver of Unit#1 he was laying in the grass in front of his vehicle. Witness#1 stated the driver was disoriented and could not stand but wanted to leave. Witness#1 stated he asked the driver how he got there. Witness#1 stated the driver advised him he had driven there to get dog food. Witness#1 stated he checked Unit#1 and the vehicle was still running and the car was in reverse. Witness#1 stated he placed Unit#1 in park and turned off the motor.
This officer could see skid marks in the grass in front of Unit#1 and could see tire abrasion marks on the concrete parking barrier, on top
