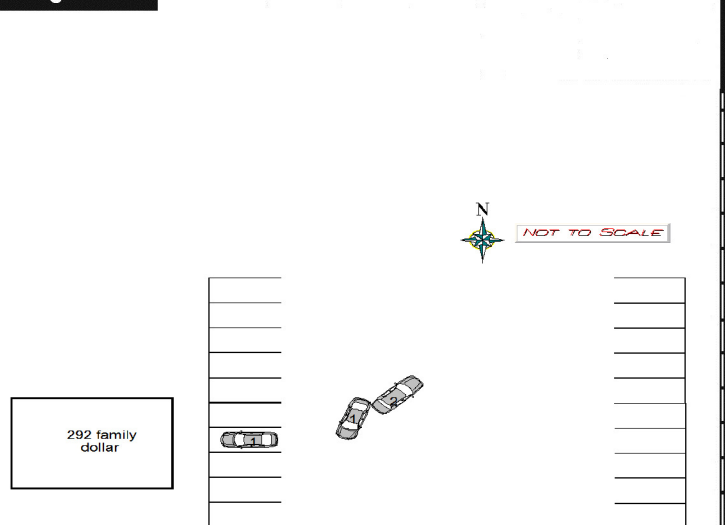

NARRATIVE

Unit#2 and I had responded to a code 4, see report# 17-26374. Unit#2 was parked in the parking lot in a clearly visible location conducting an investigation. Witness stated she observed Unit#1 back from a parking space and hit the left rear bumper of Unit#2. Unit#1 then proceeded to drive away from the area. I was able to make a traffic stop on Unit#1 and spoke to the driver. Unit#1 stated she was unaware she had struck Unit#2 but had minor damage to the left rear bumper of her car. Witness stated this was the area Unit#1 had struck Unit#2 with. Unit#1 stated she had her radio turned up and did not hear an impact nor did she feel an impact. Unit#1 information was collected and Unit#1 was released on a warning.

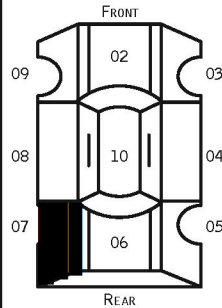

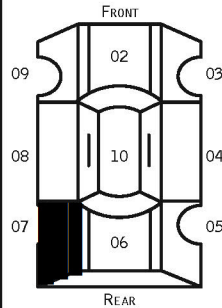
