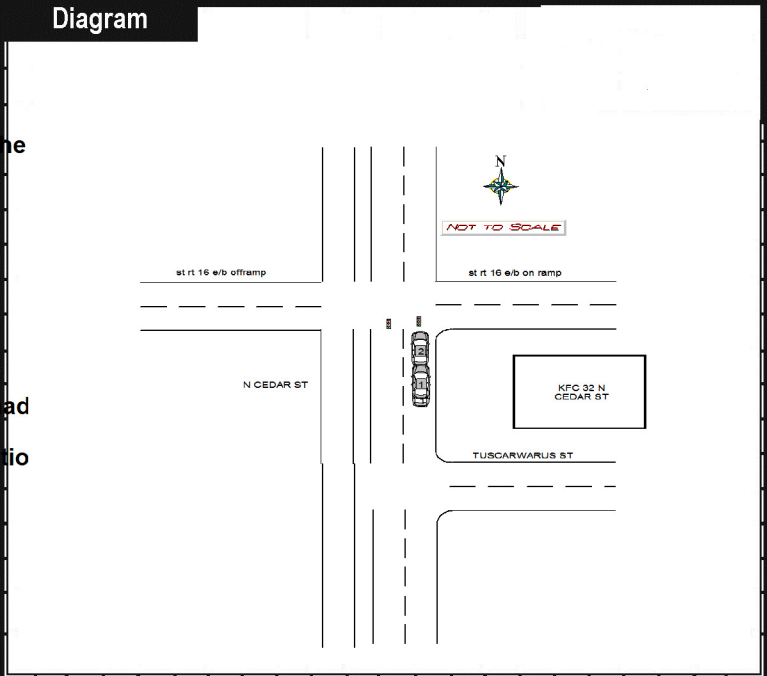

NARRATIVE

Unit#2 was stopped for the traffic light located on N Cedar St. at the St. Rt. 16 E/B on ramp entrance. Unit#2 stated the light had just turned green when Unit#1 struck her from behind. Unit#1 stated she thought Unit#2 hit a vehicle in front of her and she was unable to stop in time before striking Unit#2.

There was no damage to the front of Unit#2 and the driver of Unit#2 stated she had been followed by Unit#1 prior to the accident and had observed her talking to her passenger and not looking in the direction she was traveling. Unit#1 was cited for A.C.D.A.
