**Unit 1 was traveling s/b on N. 21st St. approaching Derby Downs Rd.**

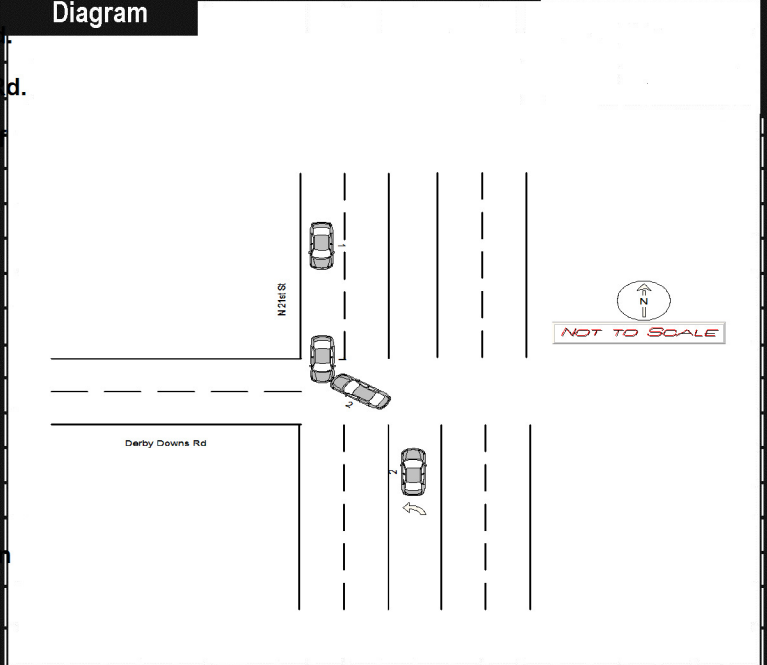
**Unit 2 was traveling n/b on N. 21st St. approaching Derby Downs Rd.**
