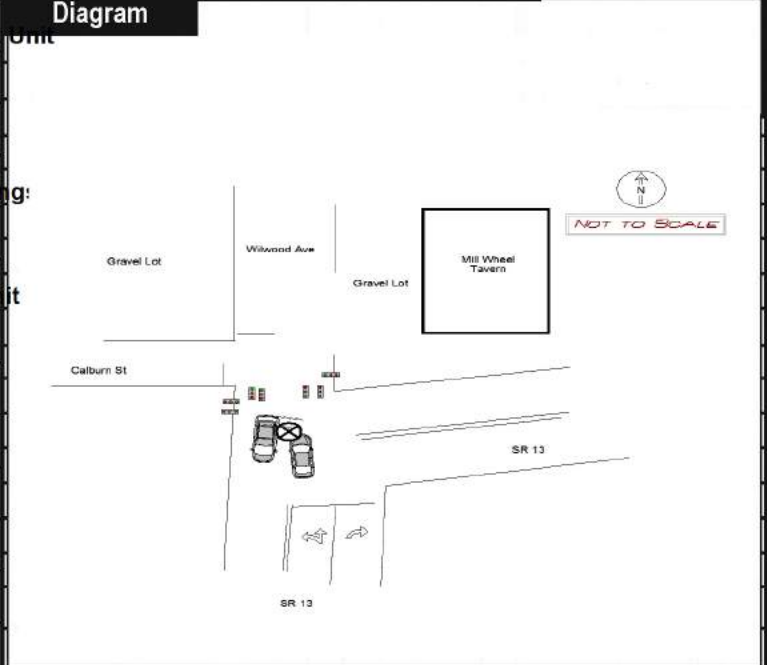

**NARRATIVE**

Unit 1 was southbound on SR 13, and states he had the green light. Unit 2 driver states that as she pulled up to the intersection, she received the green signal specific to her lane to make her turn, so she therefore entered the intersection. Due to the pavement marking, position of both vehicles, and their subsequent damage, it is this officer's opinion that unit 2's statement is more consistent than Unit 1's, meaning it is believed that Unit 1 failed to slow or stop for the traffic signal. However, this cannot be substantiated. Please see attached statement for further details.
