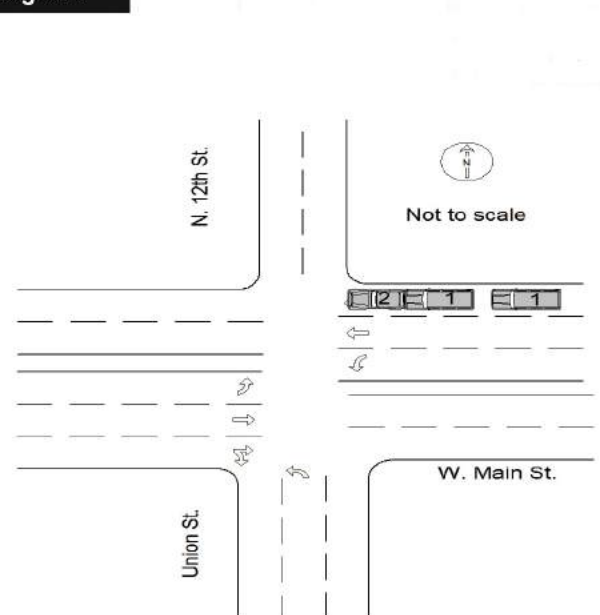
NARRATIVE

After speaking with the owner of Unit 1 who was located in the Licking County Justice Center it was determined that he lent the vehicle to Mr. Alexx Lingenfelter. The owner of Unit 2 advised me of his phone number (740-641-4123) and work location (Anamatic). I attempted to locate Mr. Lingenfelter at his work but was unsuccessful. I then tried calling Mr. Lingenfelter but he did not answer and his voicemail was full. I then sent Heath PD to his last
