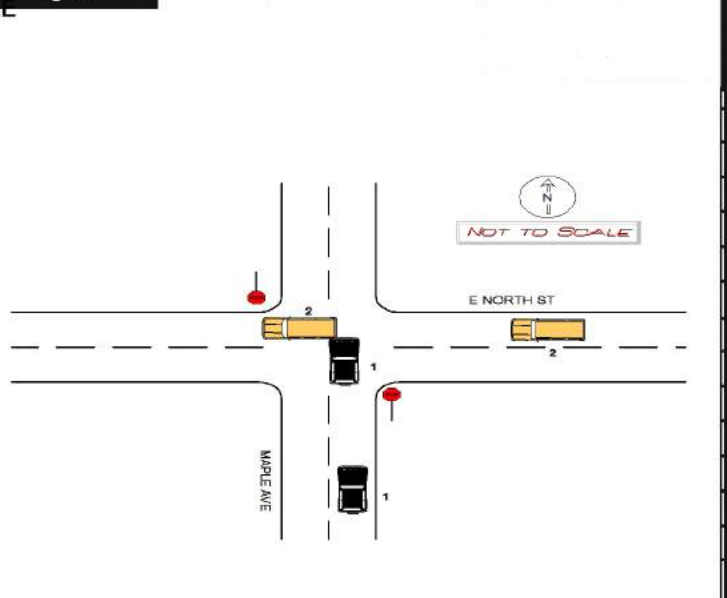

UNIT 1 FAILED TO STOP FOR THE STOP SIGN AND COLLIDED WITH UNIT 2 CAUSING MINOR DAMAGE. UNIT 1 CONTINUED NORTHBOUND ON MAPLE AVE WITHOUT STOPPING TO PROVIDE THEIR INFORMATION.
THE ONLY INFORMATION UNIT 2 COULD PROVIDE WAS THAT UNIT 1 WAS A BLK AND WHT OLDER MODEL JEEP WRANGLER WITH A WH MALE DRIVER WITH DARK HAIR.
