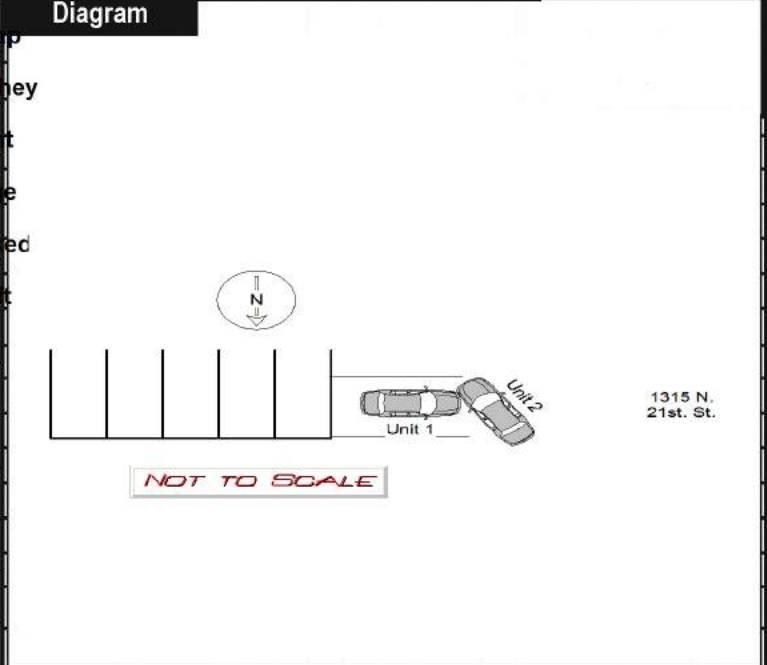
NARRATIVE
