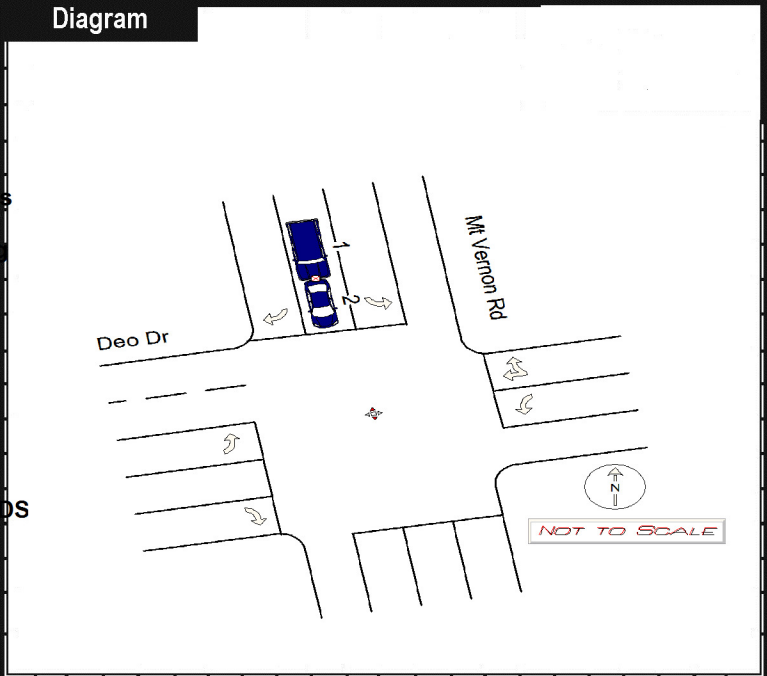

NARRATIVE

Unit 2 was on Mt Vernon Rd facing southbound and stopped at the intersection of Deo Dr. Unit 1 failed to stop and rear ended Unit 2. Unit 1 driver exited vehicle, described as mid 20s white male with short brown hair, and advised Unit 2 driver to pull into a nearby gas station. Unit 1 driver then took off southbound instead of stopping at the gas station. Unit 2 driver was able to take a picture of fleeing Unit 1, which is included in the report. Unit 1 is found at fault for ACDA and hit/skip.

Dispatch was unable to find a match for the suspect vehicle in LEADS


