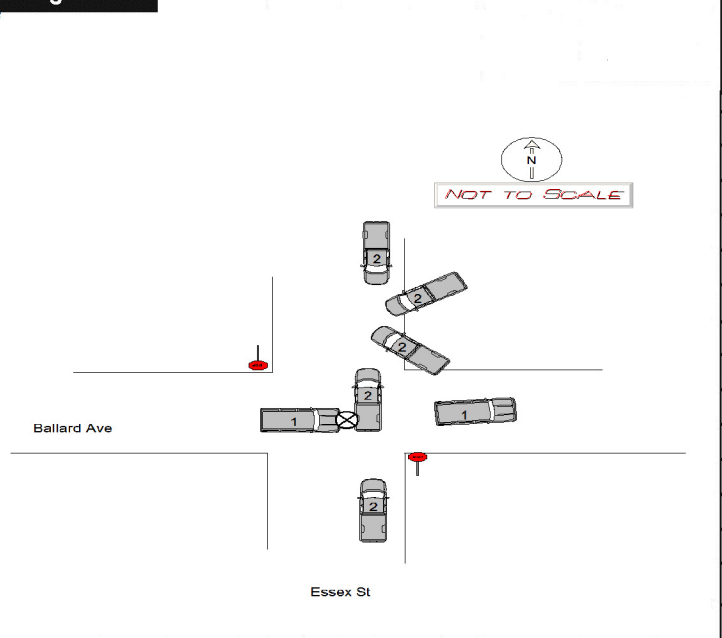
NARRATIVE

Unit 1 was traveling eastbound on Ballard Avenue and was entering the intersection at Essex Street. Unit 1 did not have any traffic control devices or signs. Unit 2 was traveling northbound on Essex Street, and had a posted (and present) Stop Sign. Unit 2 failed to stop for the posted stop sign and entered the intersection, crossing directly in front of Unit 1. Impact was center front on Unit 1, with the left rear of Unit 2. Impact caused Unit 2 to begin rotating counter-clockwise and leaving the roadway and going into the grass. Impact with the rotation caused Unit 2 to lose the left rear wheel/tire, before coming to final rest. Driver of Unit 2 was cited and released. Driver of Unit 2 did verbally admit to failing to stop at the stop sign.
