**NARRATIVE**

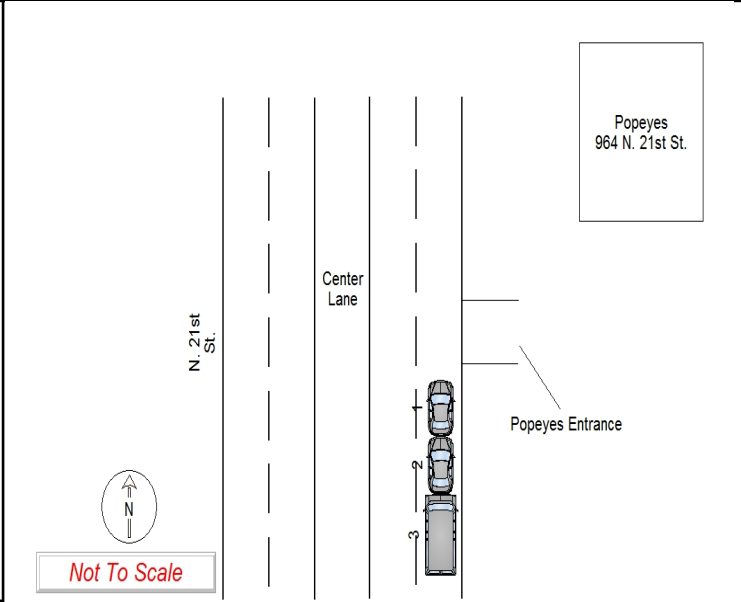
Unit 1, 2, and 3 were traveling n/b on N. 21st St. approaching Popeyes, 964 N. 21st St. Unit 1 stopped for traffic near the entrance to Popeyes. Unit 2 was able to get stopped before being struck from behind by unit 3. The collision caused unit 2 to strike the rear end of unit 1.

The driver of unit 3 stated that she saw unit 2 stop abruptly but was unable to stop in time to avoid the collision.

Unit 1 sustained minor damage to the rear bumper.

Unit 2 sustained minor damage to the front and rear bumpers. The driver of unit 2 stated that her head, neck, and back hurt slightly but did not need medical treatment on scene.

Unit 3 sustained minor damage to the front of the vehicle.
