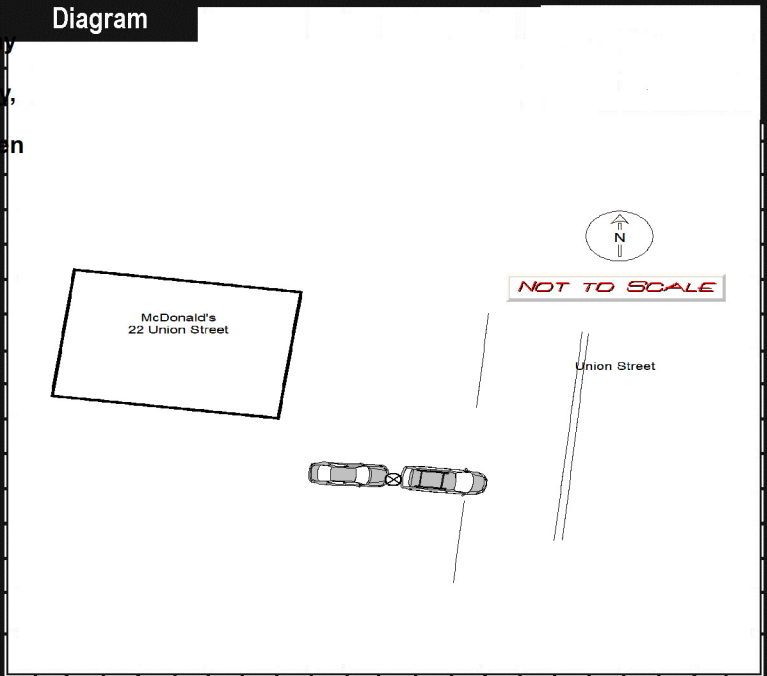

NARRATIVE

Units 1 and 2 were on private property of McDonald's at the driveway exit/entrance. Unit 1 reportedly stopped in the edge of the roadway, and Unit 2 had stopped behind them waiting to also exit. Unit 1 then began backing and struck the front end of Unit 2. An independant witness observed the crash and advised of the drivers actions.


