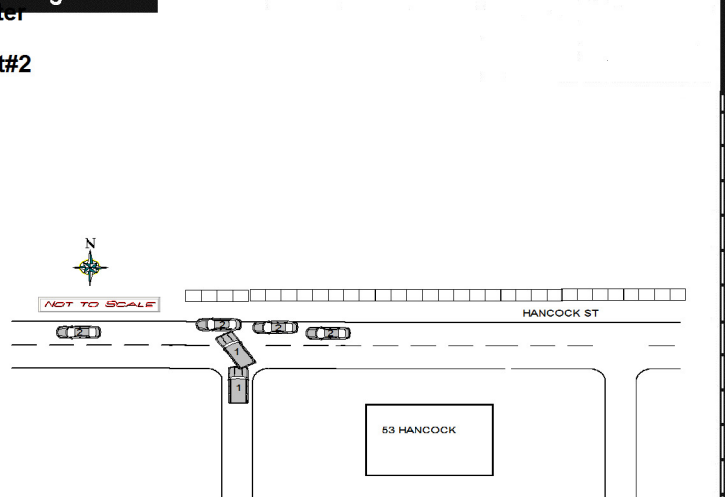

NARRATIVE

Unit#1 stated she was backed into a driveway and was preparing to enter the West bound lane of traffic on Hancock St. when she observed Unit#2 traveling West on Hancock St. Unit#1 stated she believed Unit#2 was slowing to stop so she proceeded with her turn striking Unit#2 in the left rear wheel. Unit#1 stated she stopped and stayed at the scene but Unit#1 continued to drive away. Unit#1 stated she believed Unit#2 was a gray Ford Fusion. There was a ford hub cap located at the scene of the accident. Unit#2 could not be located. Unit#1 stated she was not going to report the accident to her insurance company due to the minor damage. Unit#1 stated she just wanted the incident documented. Unit#2 was not located and did not report the accident.

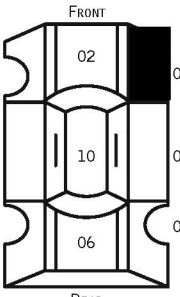
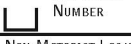

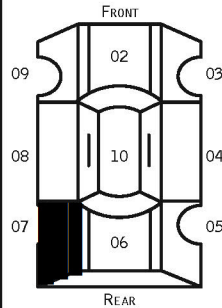
