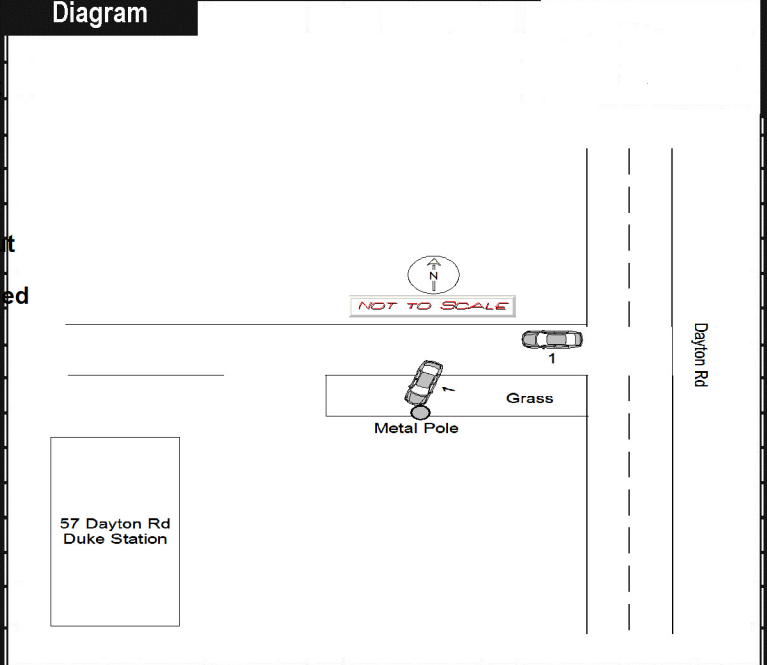

**Unit 1 was turning into the Duke Station, 57 Dayton Rd., when the driver passed out. Unit 1 drove to the left into the grass and struck a pole. The driver was checked by Newark F.D. and transported to Licking Memorial Hospital on a possible heart issue. Newark F.D. advised that the driver did not appear to be injured by the crash but had a medical issue that likely caused the crash. A metal pole owned by the Duke Station was damaged.**
