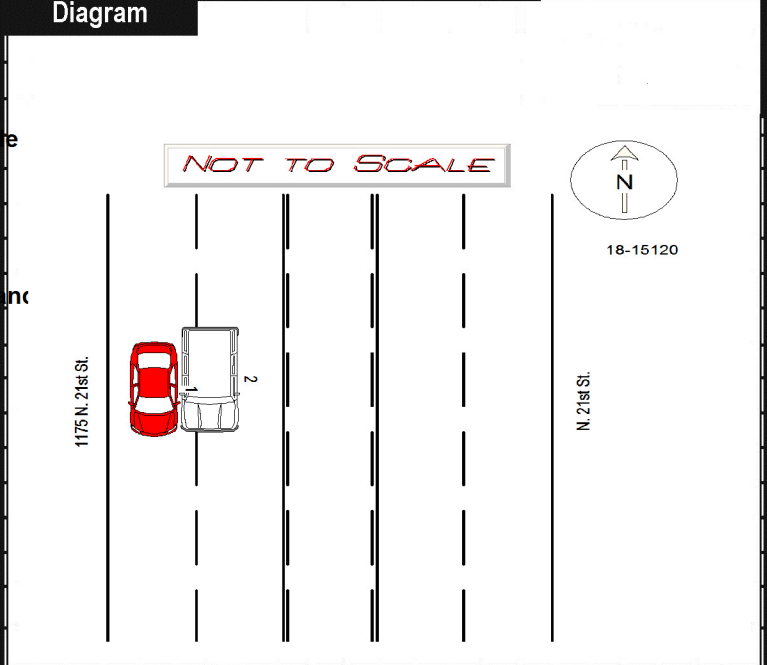

Unit #2 at fault.




