**NARRATIVE**

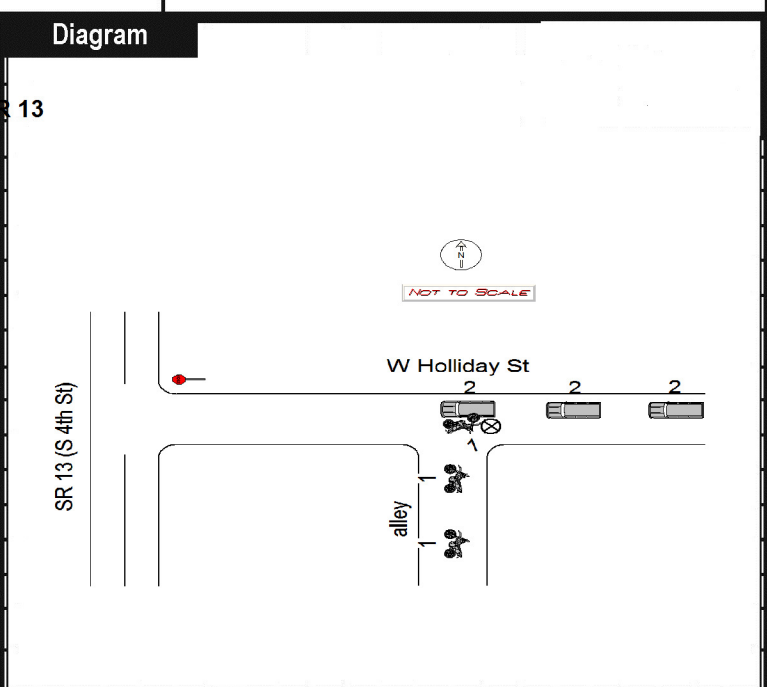
**Unit 1 (hit skip) was traveling in the alley northbound at W Holliday**


