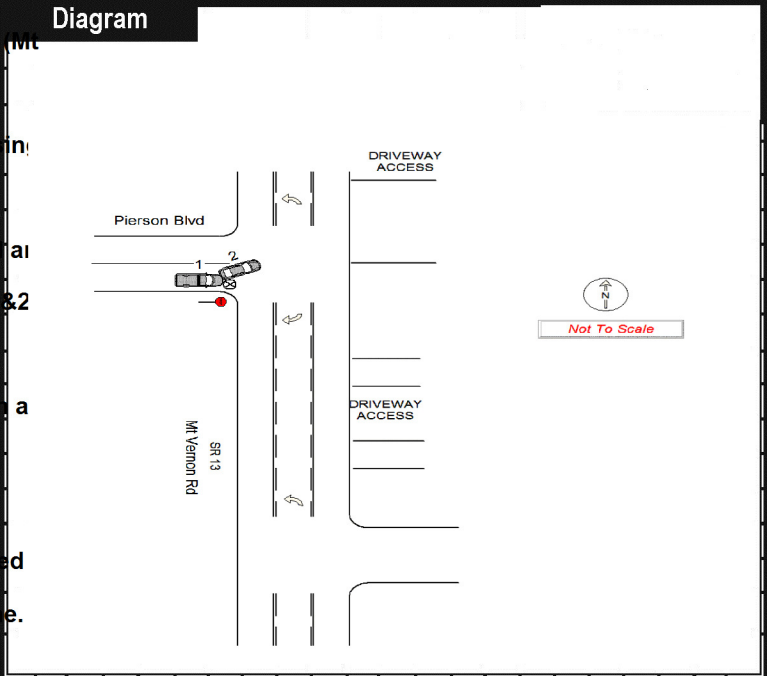

**NARRATIVE**

Unit's 1&2 were both traveling eastbound on Pierson Blvd @ SR 13 (Mt Vernon Rd) at the stop sign. Unit 2 was slowly making a left turn (northbound) onto SR 13 when Unit 1 struck Unit 2 in the rear causing an accident. Unit 2 advised she pulled off to the side of the road to report accident. Unit 1 turned right (southbound) on Mt Vernon Rd and did not stop for the accident. Witnesses who were behind Unit's 1&2 to the accident got license plate number from Unit 1. Witnesses stated Unit 1 was a yellow Ford Ranger license plate GTM1705 with a blonde hair female driver. I made contact with driver of Unit 1. Unit 1 advised she did rear end Unit 2 and fled the scene. Unit 1 advised she did not have a valid license. Unit 1 stated she panicked and did not want to get in trouble and that is why she fled the scene.


