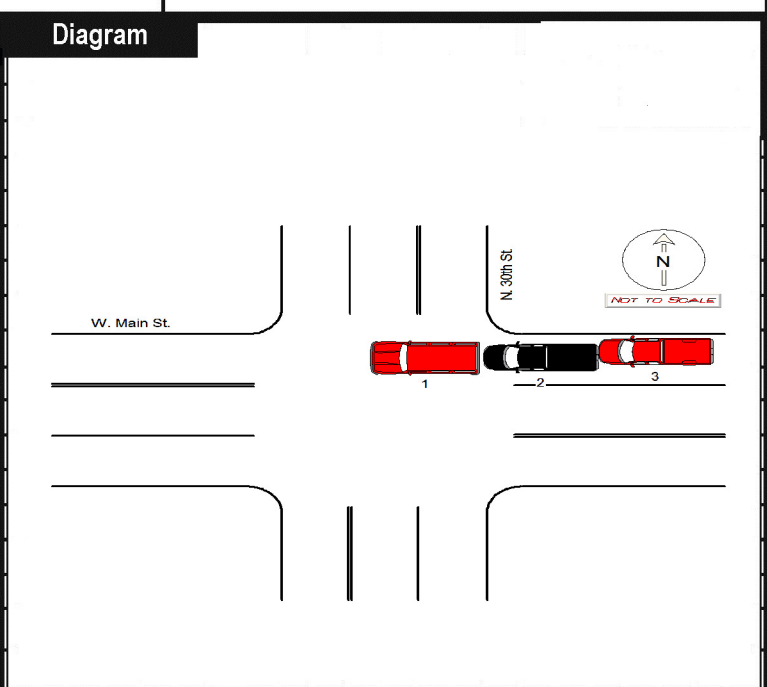

Unit #2 and Unit #3 at fault for ACDA.






