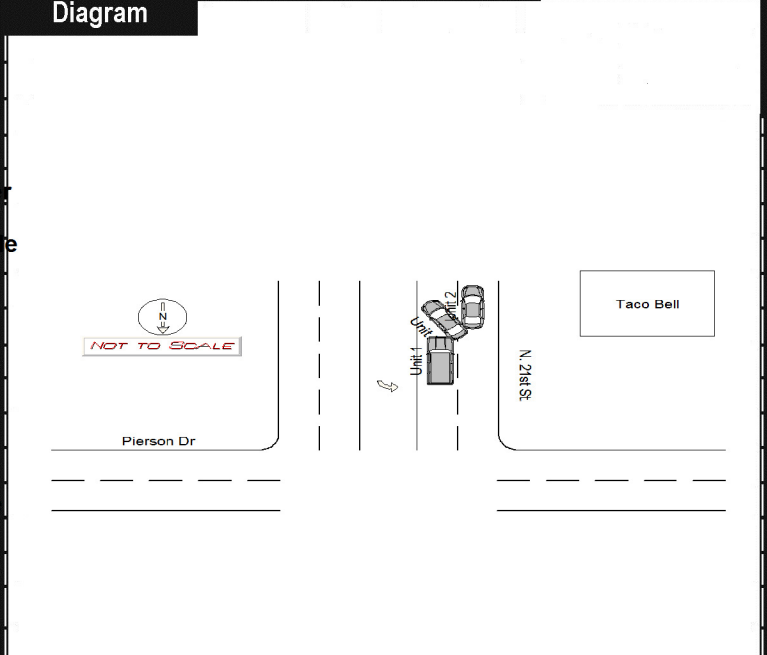

Unit 2 stopped for traffic in front of Taco Bell on N. 21st St. Unit 3 attempted to stop but began sliding. The driver of unit 3 stated that he quickly changed lanes by turning the vehicle to the left to attempt to avoid unit 2. Unit 3 pulled out in front of unit 1.**

**The front right of unit 1 struck the rear left side of unit 3. Unit 3 was then shoved into unit 2. The rear right side of unit 3 struck the rear left side of unit 2.**






