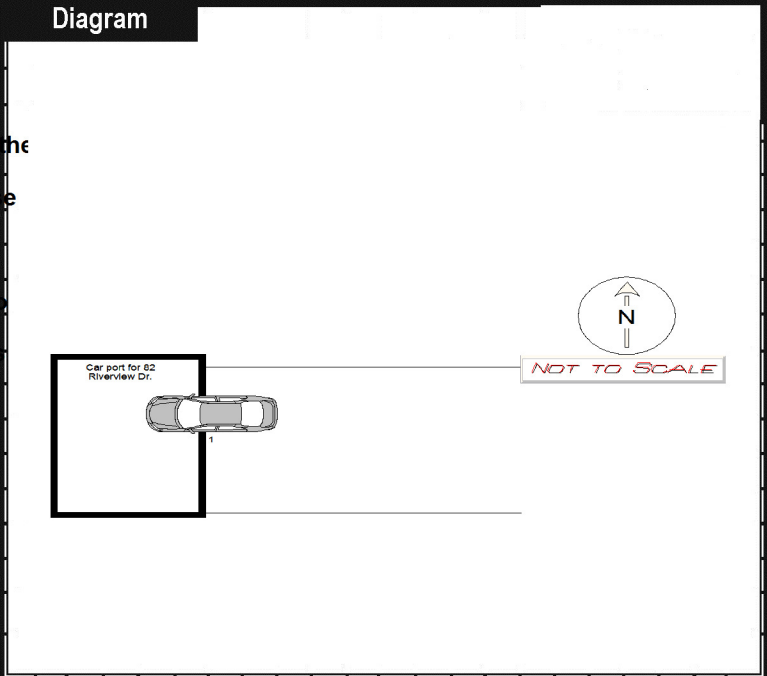

Unit #1 was on private property at 82 Riverview Dr. Unit #1 was entering a car port and very softly struck a small single pole in the middle of the car port holding up two steel I-beams which held up the roof. There was also another vehicle in the car port (a 1995 Toyota Camry Ohio registration HEG2293) which was struck by the I-beam. No injuries were reported.
